

#### COMMENT.

- 1. These figures do not represent actual revenue expenditures but simply appropriations and estimated revenue expenditures. There is, of course, an element of estimation in the classification made by the Bureau.
- 2. An item of \$900,000, not included in the official estimates, is included here by the Bureau, as representing estimated net revenue expenditures under Charities and Corrections. This is an estimated amount to be raised by five-year instalment



debentures to be issued for unemployment relief and to be repaid with interest by the taxpayers of the succeeding five years, when, presumably, they will be in a better position to meet the additional burden.

- 3. The general deficit, which appeared in the estimates of last year for the first time in over fifteen years, represents at least partly, insufficient expenditure estimates in 1932.
- 4. The "Deficits on Special Services" are the largest in total and per capita since this item appeared.

- 5. The total appropriations for Protection of Persons and Property are the lowest in total and per capita for the five years given.
- The total and per capita appropriations for "Health and Sanitation" are the lowest in the five-year period.
- 7. The total and per capita appropriations for "Recreation" are the lowest in the five-year period.
- 8. The total and per capita appropriations for "Highways" are the lowest in the five-year period.
- 9. The total and per capita appropriations for "Charities and Corrections" to be met out of Revenue are the lowest in three years. If only \$400,000 be included for "Unemployment Relief" as was done in the 1932 estimates the total and per capita estimated expenditures on "Charities and Corrections" are the largest in the five-year period.
- 10. The total and per capita Special Grants are the lowest in the five-year period.
- 11. The 1933 figure for "General Government" includes an item of \$545,000 for New York Exchange. There was no appropriation for this item in 1932. If the same provision had been made in 1932 as in 1933 and if \$350,000 had not been deducted from general debt charges in 1932 (P. 66, 1932 Estimates) the reduction in "General Government" would have been nearly \$240,000 in 1933, compared with 1932, instead of the increase shown.
- 12. The total and per capita figures for estimated expenditures, including the \$900,000 estimated by the Bureau for Unemployment Relief, are the lowest in three years as shown in the table.
